Mr. Zamudio stated there were 19 students that signed up for the heifer project. The numbers will be adjusted according to grades and interest in the project. He also stated that Valley Telephone had awarded the FFA with a \$5,000.00 grant to be used for the National FFA Convention travel.

6b. Mr. Walter gave the monthly budget report. He stated the juniors are doing well with the concession stand sales. The sophomores are selling Little Caesars pizza kits. The athletic club purchased a striping machine for the maintenance shop to be used to stripe the football field. National Honor Society will sponsor a spaghetti dinner during Parent/Teacher conferences. Their account is in the negative at this point. The seniors haven't had any fundraisers yet. Their current balance is \$5,008.00. The fall carnival will be held on October 19 so most of the classes will be having booths to raise money. He will be discussing the Annual Financial report during the action items.
